Having undergone one surgery and facing another, South Vienna resident Joe Dooley also confronted ongoing prescription drug bills he could not pay.

That's when the Clark County Department of Job and Family Services stepped in. Staff there found that Joe qualified for Medicaid assistance in paying for his prescriptions. Today, Joe's life has stabilized.

"I can't say enough about the people over there (Medicaid)," he said.
"They helped me so much."

Joe Dooley is one of about 26,000 Clark County residents who qualify

BECOME A FOSTER FAMILY

Two-year-old Da'Myron was born into a harsh world. Severe health problems, including upper respiratory difficulties and bouts of pneumonia, led doctors to predict that he would not live longer than six months.

Enter Cory and Amy Pooler of Springfield. Cory and Amy are one of many area couples regularly recruited, screened and trained to be foster parents by the Children Services

Division of the Clark County Department of Job and Family

Services. Da'Myron was placed in Cory and Amy's home, yet very soon the couple adopted the infant. At age two, Da'Myron so far has defied the odds and fills his home with energy and love.

In 2007, the adoptions of 20 children were finalized thanks to Clark County Children Services. Adoption assistance was provided to 350 children last year, and 293 children were placed in out-of-home care. Training and assistance to become foster parents, like that provided to the Pooler's, is available by contacting Clark County Children Services at 937-327-1749.

A WORK FORCE FOR OUR REGIONS FUTURE

The entry of retail giants Kohl's and Marshalls into the Springfield community in 2007, and the plant launch of TPI Composites, showcased how WorkPlus is fulfilling its responsibility to taxpayers.

"I would recommend the WorkPlus Center to any business in need of employees," said Marshalls representative Rob Vargo, whose store hired 53 people for fulltime jobs thanks largely to WorkPlus' recruitment of more than 300 applicants for jobs. Likewise, Kohl's credited its ability to hire 200 associates largely to WorkPlus, its facilities and staff.

In 2007, TPI Composites credited much to WorkPlus for its plant launch. "We were able to efficiently meet city, state and federal leaders to get infrastructure systems and permits up and running in a timely manner," said company General Manager Kevin Weldi.



In all, more than 390 employers posted openings for jobs with WorkPlus of Clark County in 2007, and 134 job placements were made from the WorkPlus Center through the Workforce Investment Act. For more information about WorkPlus services call 937-327-1961.
