a briefing on the Social Services Block Grant (SSBG) funding, which is in danger of being eliminated.

He recalled when the SSBG was first made available. It was viewed as a godsend. It was a significant resource, but more importantly, a flexible resource in that it could serve children, families, single adults and the elderly. Because of this flexibility, counties are able to use SSBG funds in those areas where they most need them. The use of funds varies not only among states, but also among counties within a state.

On September 12th, our director Bob Suver was asked to present on behalf of the National Association of Counties (NACo) and the National Association of County Human Services Administrators (NACHSA) to congressional staff in

While not every state passes through the SSBG funds to the counties, several do. NACo and its affiliate NACHSA compiled information from over 70 counties in California, Colorado, Iowa, Minnesota, New Jersey, New York, North Carolina, North Dakota, Ohio, Pennsylvania and Virginia.

Despite the difference in the use of funds overall, Adult Protective Services (APS) emerged as the most common use of SSBG funds by far. Minnesota, North Carolina and Ohio are among the states where counties rely the most on SSBG for APS. Child Welfare Services was the second most common use of funds, followed by services to individuals with disabilities. Having a resource for adults and the elderly who are in need of protective services such as investigation, homemaker, guardianship due to exploitation, self-neglect and abuse is a good example of the importance of SSBG.

State funding received by Clark County for adult protective services amounts to approximately \$5,000 annually. The SSBG is the only source of funding there is to offset the upwards of \$300,000 spent annually on well over 100 individuals that are identified. It is also used to supplement child protective services in the mental health treatment and developmental disability area. It is also critical for providing transportation to needed social service providers.


