



Ohio Prepares for Affordable Care Act

After decades of discussing the need for change, and three years of planning, the State of Ohio embarked on the first phase of replacing its 32-year-old eligibility system. Beginning October 1, Ohio residents may now go to www.Benefits.Ohio.Gov or www.healthcare.gov to seek assistance for health insurance coverage. The new Ohio Integrated Eligibility System (OIES) will be joined with the new federally operated marketplace created by the Affordable Care Act (ACA). Individuals in Ohio seeking healthcare coverage through either system will be referred to Medicaid or private coverage, depending on income.

The ACA mandates numerous changes in the Medicaid program, including the requirement that states develop an online application process based on the Modified Adjusted Gross Income (MAGI) of an applicant and, whenever possible, determine eligibility in real time.

By 2015, the system will also cover other means tested programs such as food assistance and cash assistance. Phase 1, which went into effect October 1, allows residents to apply for healthcare benefits,

At Child Support Services of Clark County, we work

with coverage beginning on January 1, 2014. This is the first of a multi-phased project designed to rollout over the next two years and is expected to be an all-encompassing platform for all healthcare related programs which will improve care for vulnerable Ohioans, increasing program efficiencies and reducing costs for Ohio's taxpayers.

The advantages of the new system will include a "no wrong door" approach with a single seamless process of applying for health coverage—regardless of where a resident applies. Residents can apply online, by phone or in person. No matter how residents apply, this will help Ohioans get the services they need while improving the customer experience by simplifying eligibility processes; increasing access to eligibility determination via the internet and mobile devices; and improving accuracy of automated eligibility determinations.
